TERMS AND CONDITIONS OF ENTRY

WE HEREBY AGREE:

a. Our son will abide by the Rules of the School and Hostel at all times and will not leave the bounds of the Hostel at any time without proper permission

b. The Head of Hostel/Headmaster is authorised on our behalf to give consent to emergency surgical operation/medical care on the advice of Medical Practitioners

c. We will pay to the Board of Trustees a deposit as set by the Board as a token of good faith and understand that failure to give four weeks written notice of intention to withdraw our son from the Hostel will result in the deposit being forfeited and that we will accept liability for payment of four weeks fee in lieu of that notice. The Board may in some circumstances waive payment of all or part of that liability as its discretion.

d. That each term's fees will be paid promptly according to the payment schedule. Unpaid accounts will incur late payment fees and collection costs.

e. That where a student has been guilty of gross misconduct and is removed from the Hostel, the Hostel fee for four weeks will still be paid and if unpaid at such time will constitute a debt owing to the board.

f. That continued tenure of a place in the Hostel is dependent upon the Boarder achieving a satisfactory level of academic and social progress according to his ability and adhering to the hostel rules.

g. We agree to the publication of our contact details in the Scinde House Parents' Directory.

h. No insurance cover is provided by the school or it's Board for student's contents or personal effects etc. The responsibility for arranging insurance cover lies with the student or the student's parents or the student's guardian.
